### Board Members

#### **Margaret Kennedy – Independent Non-Executive Director and Chair of CRISL**

Margaret Kennedy is an independent Non-Executive Director and is the Chairperson of the CRISL Board and a member of the CRISL Audit Committee.

Margaret is an experienced Non-Executive Director and currently holds the role of Chair and Non-Executive Director on the Loreto Ministries Limited Board, Non-Executive Director on the Peet Limited Board and Peet Funds Management Limited, Hobart Airport Board (including Tasmanian Gateway Holdings Corporation Pty Ltd, Tasmanian Gateway Corporation Pty Limited and Hobart International Airport Pty Limited), Non-Executive Director on the Australian Maritime Offshore Group Board (including AMOG Holdings Pty Ltd, AMOG Technologies Pty Ltd and AMOG Ventures Pty Ltd) and is a member of the Province Finance Advisory Council for the Loreto Province Australia & SE Asia. Margaret is also a member of the Fidante Partners Limited and Fidante Partners Services Limited Compliance Committee.

Margaret was formerly a Non-Executive Director on the Senex Energy Limited Board and during her tenure the company was acquired via a Scheme of Arrangement and privatised.

Margaret has over 30+ years' experience holding various Executive roles for Shell Australia, Viva Energy Australia and Viva Energy REIT (now Waypoint REIT) where she was the inaugural CEO.

#### **Catherine Dubé - Independent Non-Executive Director and Chair of Audit Committee**

Catherine Dubé is an independent Non-Executive Director of the CRISL Board and the Chair of the Audit Committee.

In that role she was responsible for the overall management and execution of the risk management strategy across the Australasian zone, including all aspects of enterprise risks spanning across strategic, financial, operational, insurance and reputational risk.
